Article VIII.

At least fifty one percent of the capital stock will be sold to service-disabled veterans as defined in 38 U.S.C. 101(2) and (16) respectively, the Department of Veterans Affairs, United States Code. Subsequent sales or transfers of these so designated capital stocks by its holders must also be sold or transferred to service-disabled veterans in order to maintain the fifty-one percent ownership of the corporation by service-disable veterans. Upon the death of the holder of the service-disable stock, the stock must be sold or transferred as described above within 10days. If this is not accomplished, the stock must be sold back to the corporation at book value so that the stock can be reissued to maintain the fifty-one percent ownership by service-disabled veterans.
