ARTICLES OF INCORPORATION

OF

JMC QUALITY SERVICES CORP.

ARTICLE I - Name

The name of this corporation is JMC Quality Services Corp.

ARTICLE II - Nature of Business

This corporation may engage in any activity of business permitted under the laws of the United States of America and of this State.

ARTICLE III - Capital Stock
