The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

### ARTICLE I Name and Principal Office

- 1.01. The name of the corporation is Charles Barnicoat PA
- 1.02. The Principal office of the corporation is: 4483 Snowy Egret Drive, Naples FL 34119
