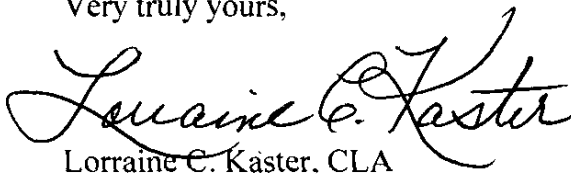

ARTICLE I - Name

The name of the corporation shall be: **MICHAEL'S CARPET CARE, INC.**

ARTICLE II - Duration

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business, including, but not limited to the following: Carpet cleaning/shampooing and all related matters. .
