ARTICLES OF INCORPORATION

<u>OF</u>

MODEL TILE & MARBLE OF SOUTH FLORIDA, INC.

<u>ARTICLE I</u>

NAME AND ADDRESS

The name of this corporation is Model Tile & Marble of South Florida, Inc., and its principal address is 4269 First Avenue N.W., Naples, Florida 34119, and its mailing address is 4269 First Avenue N.W., Naples, Florida 34119.

ARTICLE II

DURATION

This corporation shall exist perpetually commencing on the date of execution of these Articles of Incorporation.

ARTICLE III

PURPOSE

This corporation is organized to engage in the business of owning and operating a tile and marble business, sales and installation of tile and marble, and for all other purposes allowed a Florida corporation.

ARTICLE IV

CAPITAL STOCK

ARTICLE VIII

BY-LAWS

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders.

ARTICLE IX

SHAREHOLDER QUORUM

Sixty percent of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of the shareholders.

ARTICLE X

ARTICLE XI

NO REMOVAL OF DIRECTORS

An officer or director shall not be liable to the corporation for any loss or damage sustained by it for any action taken or omitted by him if he in good faith exercised the care of a prudent man, in good faith acted or failed to act based upon advice of counsel for the corporation or on the books and records of the corporation, or followed what he believed to be sound accounting and business practice.

ARTICLE XIII

<u>AMENDMENT</u>

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment to them by a two-thirds vote of the shareholders.
