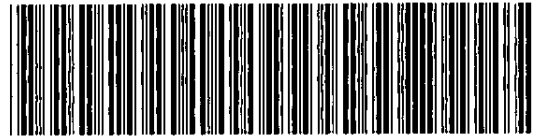

The general nature of the business to be transacted by this Corporation shall be:

ARTICLE XII LOST OR DESTROYED STOCK CERTIFICATE


