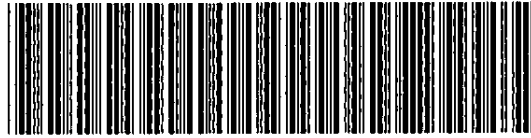

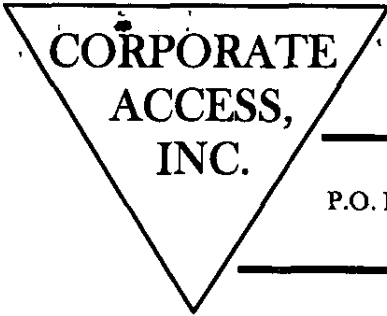

The undersigned, acting as Incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I-NAME

The name of the corporation shall be 82 SOUTH, INC.

ARTICLE II-PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 4767 New Broad Street, Orlando, Florida, 32814.

ARTICLE III-DATE OF EXISTENCE

This corporation shall exist perpetually, commencing on the date of filing of these Articles of Incorporation.

ARTICLE IV-INDEMNIFICATION

This Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE V- RESTRICTIONS ON STOCK

A. The shareholders of the Corporation may enter into written agreements concerning the transfer, voting, redemption, or issue of shares of stock of the Corporation provided that such agreements (1) are in writing and (2) comply with the provisions of the Florida Business Corporation Act, Florida Statutes 607.0101 *et seq.* Copies of any agreement which by its terms affects the transfer, voting, redemption, or issue of shares of stock of the Corporation shall be maintained at the principal office of this Corporation.

B. The shares of stock of the Corporation may not be transferred to any third party who is not already shareholder without the prior written consent of all of the other shareholders of the Corporation, which consent may be withheld for any reason or for no reason.

ARTICLE VI-CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is ONE HUNDRED THOUSAND (100,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE VII-INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The initial street address of the registered office of this Corporation in the State of Florida shall be 120 E. Concord Street, Orlando, Florida 32801. 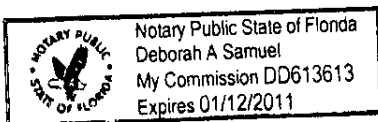


