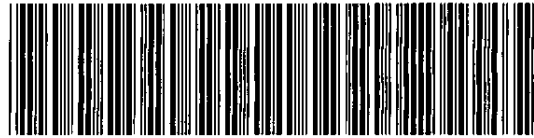

**ARTICLES OF INCORPORATION
OF

This Corporation shall have perpetual existence.




