**ARTICLES OF INCORPORATION
OF

ARTICLE I-NAME

The name of this Corporation is **C&C TIRES EXPORT AND IMPORT CORP**

ARTICLE II-DURATION

This Corporation shall have a perpetual existence commencing on the Date of Filing.
