ARTICLES OF AMENDMENT

of

CREATIVE ENVIRONS ACQUISITIONS, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, Creative Environs Acquisitions, Inc., a Florida corporation (the "*Corporation*"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is Creative Environs Acquisitions, Inc., and its Florida Document Number is P09000052406.
2. The date of filing of the Articles of Incorporation (the "*Articles*") of the Corporation was June 16, 2009.
3. That Article 1 of the Articles of the Corporation is hereby amended in its entirety to read as follows:
