

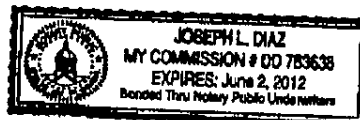
1. The name of the corporation is MTD EXPORT FOOD SALES, INC.


