ARTICLES OF INCORPORATION

OF

AFFORDABLE STORAGE OF CLAY CTY, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is AFFORDABLE STORAGE OF CLAY CTY, INC.

ARTICLE II - TERM OF EXISTENCE

The period of duration of the corporation is **perpetual**.

ARTICLE III - NATURE OF BUSINESS

This corporation is organized for the purpose of STORAGE and any other activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - AUTHORIZED SHARES

The aggregate number of shares that the corporation shall have the authority to issue is 7,500 shares of capital stock for the par value of \$.01 per share. The preemptive right of any holder is determined by a ratio of the authorized and issued shares of common stock held by the holder of all shares of common stock currently authorized and issued.
