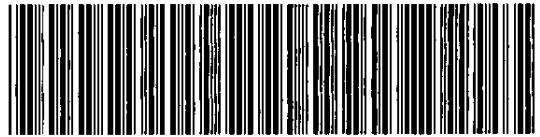





- VIII. A majority of the directors authorized the dissolution.


