ARTICLE I. NAME

The name of this corporation shall be SMPR, INC.

ARTICLE II. MAILING ADDRESS & PRINCIPAL OFFICE

ARTICLE III. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of signing of these Articles of Incorporation. This corporation's duration shall be perpetual.

ARTICLE IX. PREEMPTIVE RIGHTS

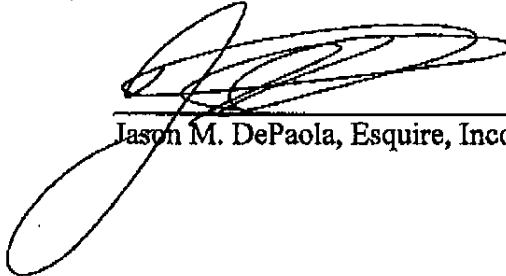
Each shareholder of the corporation shall have the first right to purchase any additional shares in the corporation which may from time to time be offered by the corporation (whether or not presently authorized), on a pro-rata basis, based upon the interest owned by each shareholder as a percentage of the total shares owned by all of the shareholders. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within the time specified in the Stockholders' and Directors' Agreement with respect to the receipt of a notice in writing from the corporation stating the prices, terms and conditions of the offer of shares and inviting such shareholder to exercise such preemptive rights. This right may also be waived by an affirmative written waiver submitted by the shareholder to the corporation within ten (10) days of receipt of notice from the corporation. Upon exercise of such preemptive right by a shareholder, full payment shall be made for the shares acquired by such shareholder within the time specified in the Stockholders' and Directors' Agreement with respect to the receipt of notice of the offer of shares from the corporation.

ARTICLE X. AMENDMENT OF ARTICLES

The power to adopt, alter, amend or repeal the Articles Of Incorporation of this corporation shall be vested in the shareholders by a unanimous vote of such shareholders.

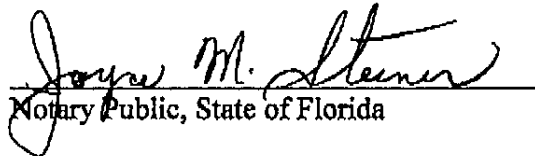

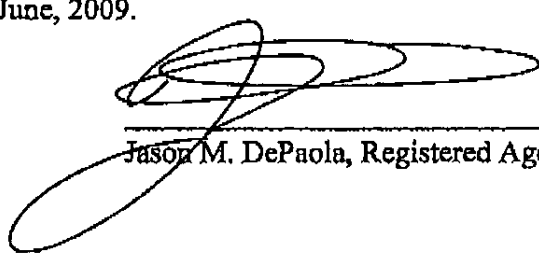
