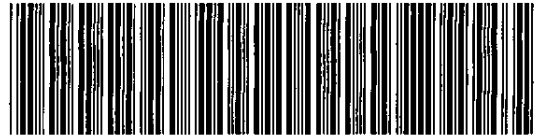


### **Corporation Article III Purpose for; "Nuts about...", Inc.**
