OF

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Spurrier Investments, Inc. Its principal office address and business mailing address is 100 SE Second Street, Suite 4000, Miami, Florida 33131, Attention: Robert B. Macaulay.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK




ACCEPTANCE OF REGISTERED AGENT
