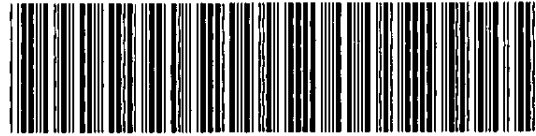

The undersigned natural person, competent and licensed to practice law in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida Business Corporation Act, and Section 621, Florida Professional Service Corporation Act of the Florida Statutes, does hereby adopt the following Articles of Incorporation.

**ARTICLE I**

The name of this corporation shall be **ROGER W. LaJOIE, P.A.** The principal office of this corporation shall be 645 Beachland Boulevard, Suite 8, Vero Beach, Florida, 32963. The mailing address of this corporation shall be 645 Beachland Boulevard, Suite 8, Vero Beach, Florida, 32963.

**ARTICLE II**

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

A. To engage in every aspect in the practice of law, and all its fields of specializations, as are engaged in by attorneys at law.

B. To engage and render the professional services involved only through its officers, agents, and employees who shall be attorneys in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation.

C. To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.

D. To engage in any other business permitted to be rendered with the rendition of the professional services specified herein.

E. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

**ARTICLE III**

A. This corporation has the authority to issue one hundred (100) shares of common stock with a par value of One Dollar (\$1.00) per share.

B. The consideration to be paid for each share shall be payable in lawful money or property, labor or services.

C. Shares of the corporation's stock and certificates shall be issued only to attorneys in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.

#### **ARTICLE IV**

This corporation is to exist perpetually.

#### **ARTICLE V**

The Registered Agent for service of process within this state shall be Roger W. LaJoie, whose street address is 645 Beachland Boulevard, Suite 8, Vero Beach, Florida, 32963.

#### **ARTICLE VI**

The name and address of the Incorporator is Roger W. LaJoie, whose street address is 645 Beachland Boulevard, Suite 8, Vero Beach, Florida, 32963.

#### **ARTICLE VII**

This corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time as provided in the By Laws, but shall never be less than one (1). The name and address of the sole member of the first Board of Directors is: Roger W. LaJoie, whose street address is 645 Beachland Boulevard, Suite 8, Vero Beach, Florida, 32963. This Director shall hold office until the first annual meeting or until his successor is elected or appointed and qualified as provided in the By Laws.

#### **ARTICLE VIII**

This corporation shall indemnify any officer, director, or any former officer or director, to the full extent permitted by the laws of the State of Florida.

#### **ARTICLE IX**

The power to adopt, alter, amend or repeal the By Laws for this corporation shall be vested in the Board of Directors and stockholders, provided any such amendment shall be in compliance with the laws of the State of Florida governing a Professional Service Corporation.


