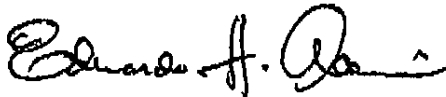
Article VIII - Beginning of Corporate Existence

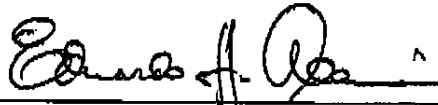

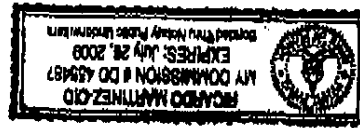
