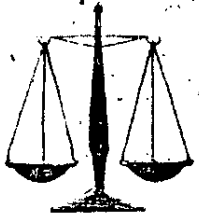


ARTICLE X OTHER PROVISIONS
