ARTICLES OF INCORPORATION OF REGAL KIA, INC.

The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I Name

The name of this corporation shall be: REGAL KIA, INC.

ARTICLE II Principal Office and Mailing Address
