The undersigned, Incorporator to these Articles of Incorporation, a natural person SECRETARY OF STATE competent to contract, hereby forms a Corporation under the Laws of the State Of Floridal LLAHASSEE, FLORIE

#### Article 1

The name of the Corporation shall be B & J Handy Service, Inc.

#### Article 2

The principal place of business and mailing address of the Corporation is 10628 Old Grove Circle, Bradenton, FL 34212

#### Article 3

The maximum number of shares of stock that this Corporation is authorized to have outstanding is one thousand (1,000) shares of one class of stock with no par value.
