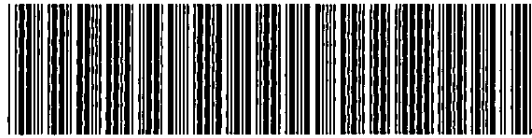

The name of this Corporation is: Edge International of South Florida Inc.




