ARTICLE I

Name. The name of this corporation is CASH N IN, INC.

ARTICLE II

<u>Duration</u>. The corporation shall be perpetual.

ARTICLE III

<u>Purpose</u>. This corporation is organized for the purpose of transacting any or all lawful business.
