The Amendment to the Articles of Incorporation of the Company is as follows:

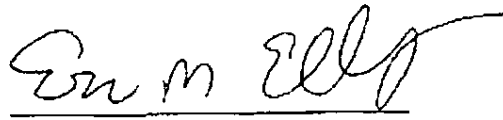
1. Article I of the Articles of Incorporation of the Company is hereby deleted in its entirety and replaced with the following:
