Kade Faulkner

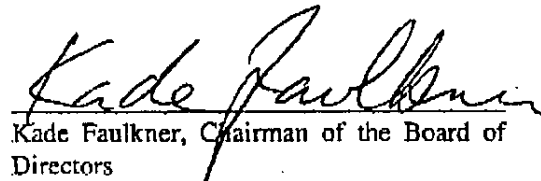
