**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
NEXT CALA, INC.
(A Florida Corporation)**

Pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act, the undersigned hereby adopts the following Amended and Restated Articles of Incorporation:

1. The name of the corporation is **NEXT CALA, INC.** (the "Corporation"). The date of filing the original Articles of Incorporation with the Secretary of State was July 10, 2009, as amended from time-to-time thereafter.

2. The Amended and Restated Articles of Incorporation were adopted and approved by the Board of Directors of the Corporation by written consent dated October 2, 2012, without shareholder action and shareholder action was not required, in accordance with Sections 607.1002, 607.1006, and 607.1007 of the Florida Business Corporation Act.

3. The Articles of Incorporation are hereby amended and restated in their entirety as follows:

**ARTICLE I
NAME**

The name of the corporation is **NEXT CALA, INC.**

**ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal place of business and mailing address of the Corporation is 100 N. Biscayne Boulevard, 9th Floor, Miami, Florida 33132.

**ARTICLE III
PURPOSE**

The purpose for which the Corporation is organized is to engage in any lawful act or activity for which a corporation may be organized under the Florida Business Corporation Act.

**ARTICLE IV

The Corporation shall exist perpetually unless dissolved according to law.

CAPITAL STOCK


