The undersigned, for the purpose of forming a corporation under Chapter 607 and Chapter 621, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Incorporation.

ARTICLE I - NAME

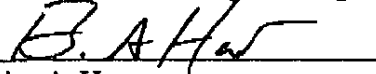
