THE UNDERSIGNED, natural person(s) of legal age, acting as incorporator(s) for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is CaribbeanFinder.Com, Inc.

ARTICLE II - PRINCIPAL OFFICE

The Principal place of business of the corporation is 522 Hunt Club Blvd # 543 Apopka, Florida 32703.

ARTICLE III – PURPOSE (S)

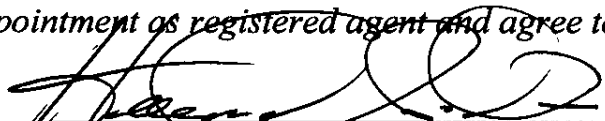

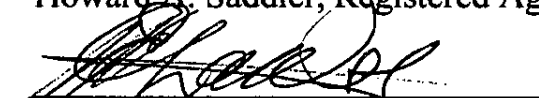
