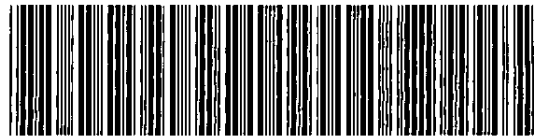

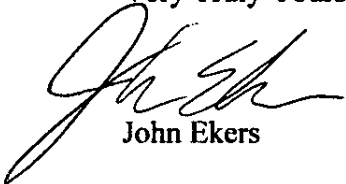
Gentlemen:

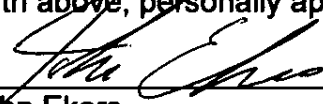

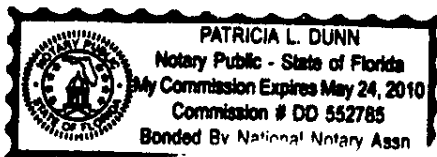

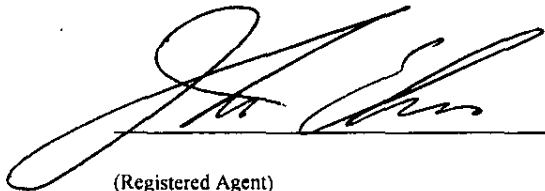
