
Please be advised that Life Worth Living Foundation Inc. is dissolving its Florida not for profit Corporation and have no intention to restart as a not for profit entity ever again.

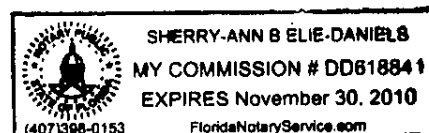




