For the purpose of forming a corporation under Florida law, the incorporator hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name and address of this corporation shall be TRAVELERS REST CABLEVISION, INC., 17243 PALAMINO LAKE DRIVE, DADE CITY FL 33523

ARTICLE II. DURATION

The duration of this corporation shall be perpetual.

ARTICLE III. PURPOSE

The purpose of this corporation shall be residential construction, and any other lawful business for which a corporation may be incorporated under the Florida General Corporation Act.
