SECOND AMENDMENT
TO
ARTICLES OF INCORPORATION

360 ADVANCED, P.A.

Pursuant to the provisions of Chapter 607, Florida Statutes, 360 Advanced, P.A. (the "Corporation") has adopted the following Second Amendment to its Articles of Incorporation.

FIRST: The name of the Corporation is 360 Advanced, P.A. The document number assigned by the Florida Department of State is P09000060900.

SECOND: The following amendment to the Articles of Incorporation was adopted by the Corporation:

"Article 1, in its entirety, of the First Amended Articles of Incorporation of the Corporation be and hereby is revoked, and in lieu thereof, the following article is adopted, approved and ratified:

ARTICLE 1
NAME

The name of the Corporation is "360 Advanced, Inc."

THIRD: The foregoing amendment was approved and adopted by the unanimous written consent of the directors and shareholders entitled to be cast on the amendment pursuant to F.S. 607.0821 and 607.0704 as of December 11, 2015.
