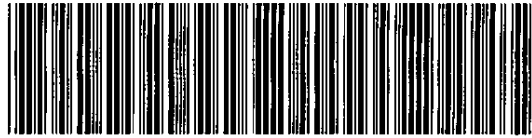

Article I

Article II

By-Laws. The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and Shareholders.


Article VII

Incorporator. Jose R. Quintana, 12620 Catamaran Place, Tampa, Florida 33618.

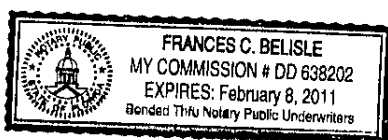


