The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I Name

Section 1.1. Name. The name of this corporation shall be BARTON FILMS, INC.

Article II Principal Office and Mailing Address

<u>Section 2.1</u>. <u>Principal Office and Mailing Address</u>. The principal place of business and mailing address of this corporation shall be **5013 Ortega Forest Drive**, **Jacksonville**, **Florida 32210**.

Article III Capital Stock
