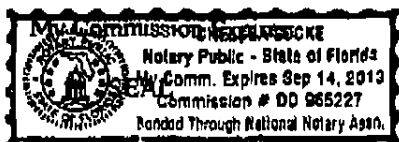
1. TEXT OF AMENDMENT. The name of the corporation shall be changed to PALM COAST LANDSCAPING, INC.
