

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation

Act, hereby adopts the following Articles of Incorporation.

## **ARTICLE I: NAME**

The name of the corporation shall be: TECH STUDIO, INC.

## **ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 4575 St. Johns Ave, Suite 2, Jacksonville, Florida, 32210.

#### **ARTICLE III: EXISTENCE AND DURATION**

This corporation shall exist perpetually commencing on July 13, 2009.

#### **ARTICLE IV: PURPOSE**

This corporation is organized with the general powers named in Chapter 607, Florida Statutes, currently in effect or as amended, to include but not limited to the right:

1. To manufacture, construct, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with products, goods, wares, merchandise, real and personal property and services of every kind, class and description.


