**ARTICLES OF AMENDMENT
OF

The name of the corporation is Amelia Island Management Inc. (the "Corporation") and its document number is P09000061800

The Articles of Incorporation of the Corporation as heretofore granted by the Secretary of State of the State of Florida on July 21, 2009 (the "Articles"), are hereby amended as follows:

The name of the corporation is:


AIM Assets, Inc."
