ARTICLES OF INCORPORATION

OF

HI-TECH QUALITY AIR, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I-NAME

The name of this corporation is Hi-Tech Quality Air, Inc.

The principal office is located at 4385 NW 203 Street. Miami, Florida 33055

ARTICLE II-PURPOSE

This corporation is organized for the purpose of doing HVAC repairs, installations and services permitted under the laws of Florida.

ARTICLE III-CAPITAL STOCK

This corporation is authorized to issue 10 shares of \$ 1.00 par value common stock, which shall be designated as "Common Shares." All of said stock shall be payable in cash, property (real or personal) or labor or services in lieu thereof at a just valuation to be fixed by the board of directors.
