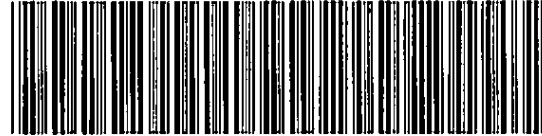



Pursuant to the provision of section 607.1006, Florida Statutes, this Florida For Profit Corporation adopts the following amendments to its Articles of Incorporation:

FIRST: The present name of the corporation is: JA AIRPORT SERVICES, INC.

SECOND: Amendment adopted: Article one (I) being amended to read:
The name of the corporation is JA MANAGEMENT SERVICES, INC.

THIRD: Amendment adopted: Article four (IV) being amended to read: The Corporation is authorized to have one class of outstanding stock, designated as Common Stock. The maximum number of Capital Stock this corporation is authorized to have outstanding at any time is ten thousand (10,000) shares of Common Stock, having a par value of one dollar (\$1.00) per share
