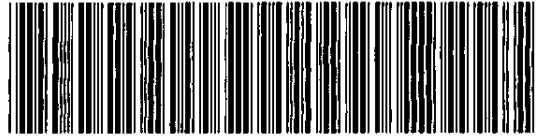



Affidavit to Release Corporation name for New Articles of Incorporation


