ARTICLES OF INCORPORATION

THE UNDERSIGNED do hereby associate for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as follows:

ARTICLE I - NAME

UNIVERSAL CAR RENTALS, INC.

ARTICLE II - PURPOSE

- A. To carry on and engage in the business acquiring, renting, marketing, leasing, selling, trading, hiring and use of motor vehicles and all acts necessary and/or related thereto;
