ARTICLES OF INCORPORATION
OF
JOHN C. SHIRK, INC.

The undersigned, acting as incorporator of JOHN C. SHIRK, INC. under Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is JOHN C. SHIRK, INC. (the "Corporation").

ARTICLE II. MAILING ADDRESS AND OFFICE


ARTICLE VIII. BYLAWS

ARTICLE IX. AMENDMENTS


