ARTICLES OF INCORPORATION

OF

SICONTEK, INC.

ARTICLE I

The name of the corporation is Sicontek, Inc. (the "Corporation")

ARTICLE II

The street address and mailing address of the Corporation is: c/o Coradin Law Group, 1111 Brickell Avenue, Suite 1100, Miami, FL 33131.

ARTICLE III

The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act, as the same exists or may hereafter be amended (the "Act").

ARTICLE IV

Section 4.1: The Corporation is hereby authorized to issue two million (2,000,000) shares with no par value, of which one million (1,000,000) shares shall be Common Shares and one million (1,000,000) shall be Preferred Shares. Except as set out in Section 4.2, all limitations, rights and preferences of Common Shares and Preferred Shares shall be set out in the Corporation's Bylaws.

Section 4.2 Preferred Shares Provisions

- a. The Board of Directors may divide the Preferred Shares into one or more series and, with respect to each series, fix and determine the limitations, preferences and rights thereof by resolution or resolutions providing for the issue of such series, including without limitation:
 - i. The designation and number of shares;
 - ii. The dividend rate, when to declare and when to pay a dividend;
 - iii. Redemption rights;
 - iv. Conversion rights;
 - v. Voting rights.
- b. All shares of any one series of Preferred Shares shall be *pari passu* with each other in all respects, except that shares of any one series issued at different times may differ as to the dates from which dividends thereon shall be cumulative. All series of Preferred Shares shall be *pari passu*, except as permitted by this Article III.




