## ARTICLES OF INCORPORATION

OF

The undersigned, acting as subscriber of a corporation under the Florida Corporation Law, adopt the following Articles of Incorporation for such corporation:

#### ARTICLE I

#### NAME

The name of the corporation is RJR ADVENTURES, IN

## ARTICLE II

## DURATION
