

ARTICLE I - NAME

The name of the corporation is MAJOR TILE & STONE, INC.

ARTICLE II-NATURE OF BUSINESS

The general character, purpose, and nature of business to be transacted by this corporation are to carry on in any capacity and business or trade deemed legal in the State of Florida.

<u> ARTICLE III - CAPITAL STOCK</u>

The mattmum number of shares of stock that this corporation is authorized to have outstanding at any time is 500 shares of common stock, each share having a par value of \$1.00.
