Articles of Incorporation of . Nelson Medina [r., P.A.

The undersigned natural person, who is licensed or otherwise legally authorized to practice the profession of Real Estate in the State of Florida, hereby forms this association with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopt the following articles of incorporation for such corporation:

ARTICLE I

The name of this corporation is Nelson Medina Jr., P.A.

ARTICLE II NATURE OF BUSINESS

The corporation is organized for the purpose of transacting Real Estate and Closings Services in Florida.

ARTICLE III TERM OF EXISTENCE

The duration of the corporation is perpetual.

ARTICLE IV CAPITAL STOCK AND CAPITALIZATION

The total number of shares of capital stock which the corporation shall be authorized to issue is1000 shares. Such shares shall be of a single class of common stock, and shall have a par value of One dollar (\$1.00) per share.
