ARTICLES OF INCORPORATION

PREAMBLE

The undersigned, desiring to form a for-profit corporation under the Florida Business Corporation Act, Chapter 607, *Florida Statutes*, does hereby certify and acknowledge the following:

ARTICLE I

The name of the corporation shall be "N4923T Corporation" (hereafter, "Corporation")

ARTICLE II

The principal place of business and mailing address of the Corporation shall be 2801 Flight Safety Drive, Vero Beach, Florida 32960.

ARTICLE III

The purpose of the Corporation shall be to own and hold title for a 1972 Piper Arrow 28R-200, Serial Number 28R-7235160, currently on the U.S. Registry as tail number N4923T, and any other assets the Board may wish to assign the Corporation. 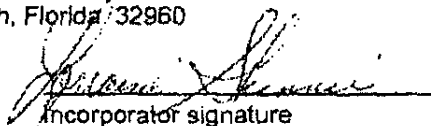

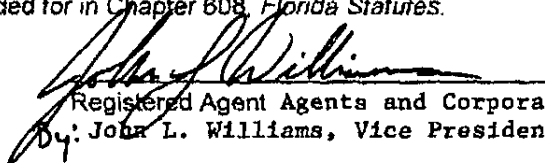
