**ARTICLES OF INCORPORATION  
OF

These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida Business Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

**ARTICLE 1  
NAME AND ADDRESS**

The name of this corporation shall be BLUE WATER ENTERPRISES OF NAPLES, INC. The initial principal business address of the corporation is 11630 Red Hibiscus Drive, Bonita Springs, Florida 34135.

**ARTICLE 2  
DURATION**

The corporation shall commence upon the filing of these Articles and shall have perpetual existence thereafter.
