


ARTICLE IX - BYLAWS

The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, has executed these articles of incorporation this 2nd day of August, 2009.

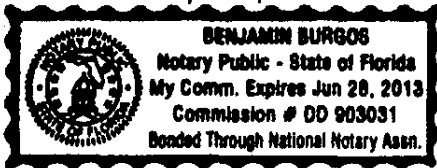
