ARTICLES OF INCORPORATION

OF

AGAPE GARDENS, INC.

I the undersigned incorporator of a Corporation under the Florida General Corporation Act adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the Corporation is Agape Gardens, Inc.

ARTICLE II. NATURE OF BUSINESS


